In the last 12 months, the Labour government, elected in 2024, has introduced a more proactive housing agenda, including a pledge to deliver 1.5 million new homes by 2030, with a strong emphasis on social rent and the Regulator of Social Housing (RSH) continues to emphasise transparency, tenant influence, and accountability, aligning with post-Grenfell reforms and the Social Housing Regulation Act.

We are honoured to have a Rhiannon Davies a Senior Resident Engagement Manager from the Regulator of Social Housing with us today as well as Verity Richards Head of Duty to Monitor at the Housing Ombudsman Service. This year, the government launched a bold new initiative titled "Delivering a Decade of Renewal for Social and Affordable Housing." Backed by a £39 billion investment, the plan aims to tackle long-standing issues in the sector by boosting grant funding, empowering councils to build at scale again, and strengthening regulation. With over 1.3 million people on waiting lists and thousands of families in temporary accommodation, this policy marks a significant step toward delivering safe, affordable, and high-quality homes for all.

Before we begin our main events, I want to express my appreciation to the ARCH Tenant Group members that have supported in planning today's conference. Without your support it would not be possible.
